

## Policy: Schedule of Fines

Violations will be issued by citation mailed to the members address by regular US mail or by personnel service by LLPOA employee.

To maintain safety on the roadways and the waterways, within the boundaries of the Association, certain regulations and speed limits have been established. The roadways speed limit has been established at a maximum of twenty-five (25) miles per hour, with a speed limit of twenty (20) miles per hour at the bridge. Signs are posted in numerous places and on numerous roads within the boundaries of the Association. There are also numerous STOP signs placed throughout the Lake and at various intersections. The waterways speed limit has been established at a maximum speed of forty (40) miles per hour. These rules are contained in the LLPOA comprehensive regulations.

In order to regulate these rules, the Board of Directors of the Association has adopted a schedule of fines as follows:

### Roadways Violations

#### Speeding (licensed and unlicensed vehicles)

Member:

All Offenses	\$ 75.00
If Not Paid within 30 days	\$ 150.00
If Not Paid within 60 days	Loss of Lake Privileges (2.27.2020 BOD mtg)

#### Traffic Control (Stop signs, etc...)

Member:

Stop Sign Violation:	All Offenses	\$ 50.00 (2.27.2020 BOD mtg)
----------------------	--------------	---------------------------------

Non-member:

1 <sup>st</sup> Offense:	Written Warning
2 <sup>nd</sup> Offense:	Prohibited from Lake Latonka roads for a period of one (1) year
3 <sup>rd</sup> Offense:	Driving on LLPOA roads shall be treated as DEFIANT TRESPASS upon LLPOA property and charged to a District Judge

#### Fleeing and Eluding (licensed and unlicensed vehicles)

Member:

\$500.00 fine, plus cost, plus suspension of membership privileges, for a time frame specified by the LLPOA Board of Directors

Non-member:

1 <sup>st</sup> Offense:	Prohibited from Lake Latonka roads for a period of one (1) year
2 <sup>nd</sup> Offense:	Driving on LLPOA roads shall be treated as DEFIANT TRESPASS upon LLPOA property and criminal proceedings may be instituted by LLPOA.

### Waterways Violations

#### Speeding (power and personal watercrafts)

1 <sup>st</sup> Offense:	Written Warning
2 <sup>nd</sup> Offense:	\$25.00 fine, plus costs
3 <sup>rd</sup> Offense:	\$100.00 fine, plus costs
4 <sup>th</sup> Offense:	\$200.00 fine plus costs, plus loss of membership privileges for thirty (30) days
1 <sup>st</sup> Offense:	\$50.00 fine, plus costs – (56 + mph)
2 <sup>nd</sup> Offense:	\$200.00 fine, plus costs
3 <sup>rd</sup> Offense:	\$300.00 fine plus costs, plus loss of membership privileges for 1 week

**Within Restricted Areas** (no-wake zones (white water coming from propeller), dams/spillway/swimming area, within 100 feet of shore, slalom course (when in use), etc...)

- 1<sup>st</sup> Offense: Written Warning
- 2<sup>nd</sup> Offense: \$50.00 fine plus costs
- 3<sup>rd</sup> Offense: \$100.00 fine plus costs, Referral of Fish Commission, plus thirty (30) day suspension of membership privileges.

**Skiing** (water, jet, kite skiing, tubing, and similar athletics)

Within Restricted Areas (no wake zones (white water coming from propeller), dam/spillway/swimming area, within 100 feet of shore, etc...)

**Others**

**Wrong Direction:**

- 1<sup>st</sup> Offense: Written Warning
- 2<sup>nd</sup> Offense: \$25.00 Fine
- 3<sup>rd</sup> Offense: \$50.00 Fine

**Personal Watercraft and Water Skiing after Sunset:**

- 1<sup>st</sup> Offense: Written Warning
- 2<sup>nd</sup> Offense: \$50.00 fine plus costs
- 3<sup>rd</sup> Offense: \$100.00 fine plus costs and thirty (30) day suspension of membership privileges

**Unauthorized/Illegal Boats Violations**

- Member: Written Warning
- Non-member: Written Warning and Instant Removal

**Motorized Watercraft on Water During Drawdown:**

\$100.00 Fine plus 2 weeks loss of membership privileges

**Watercraft Permit Stickers / ATV / Off Road / Golf Cart Permit Stickers**

Reckless Operation (including speeding, lack of safety equipment, riding in restricted area)

- 1<sup>st</sup> Offense: \$25.00 fine plus costs
- 2<sup>nd</sup> Offense: \$100.00 fine plus costs
- 3<sup>rd</sup> Offense: \$300.00 fine plus costs and suspension of membership privileges, for a time frame specified by the LLPOA Board of Directors

Lack of Current Sticker – through April 30<sup>th</sup>

After – May 1<sup>st</sup>

**Pet Violations:**

Failure to control – per LLPOA regulations:

- 1<sup>st</sup> Offense: Written Warning
- 2<sup>nd</sup> Offense: \$ 50.00 fine, plus costs
- 3<sup>rd</sup> Offense: \$100.00 fine, plus costs, and suspension of membership privileges, for a time frame specified by the LLPOA Board of Directors

**\*\*Members are responsible for all violations of their Watercraft(s) – regardless of operator**
